

SHIPPED SEMEN STALLION SERVICE CONTRACT

This certifies _____, herein referred to as Mare Owner, has engaged one breeding to Casino Cool for the _____ season at \$ _____ breeding fee for the mare _____ Breed: _____ Registration #: _____

Stricklin Quarter Horses, agent for the above named stallion, will herein be referred to as Breeder.

This service is engaged subject to the following:

- 1) A non-refundable booking fee of \$300.00 is payable with this contract. The balance of \$ _____ and service charge for the first shipment (see #5 below) are due before any semen will be shipped.
- 2) A photocopy of registration papers shall be sent to the Breeder with this contract.
- 3) Shipping days will be Monday, Wednesday, Friday, beginning February 1 and ending July 1, 2010.
- 4) The Breeder must be notified prior to 9:00 am Central Time on the date the semen is to be shipped. Semen will be shipped on collection days only and on an "as available" basis.
- 5) Shipped semen service charge will be as follows: Federal Express Priority Overnight at \$300.00 per shipment or by commercial air at current rates (contact Breeder for rates).
- 6) Mare Owner is responsible for returning shipping container immediately to Breeder (at Mare Owners expense) or will be charged a \$40 container fee.
- 7) Live Foal Guarantee: Live Foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is stillborn, a return breeding will be guaranteed the following year if Breeder is provided with written notification by a licensed veterinarian within seven days of the mares failure to produce a viable foal.
- 8) Rebreed: If the mare does not produce a live foal the first season bred, Mare Owner is entitled to a rebreed the following year. Thereafter, Mare Owner will be subject to an additional chute fee, plus the current breeding fee.
- 9) A breeders certificate will be issued to the Mare Owner after all expenses have been paid in full and Breeder has received notification of a live viable foal.
- 10) It is agreed that should above named stallion die or become unfit for service, then this contract will become null and void and the booking fee refunded. For those with a paid return breeding the Mare Owner may select from another stallion standing at Stricklin Quarter Horses.
- 11) This contract is governed by the laws of the state of Mississippi and the venue of Yazoo County, MS.
- 12) All fees are due and payable in U.S. dollars to Stricklin Quarter Horses in Yazoo County, MS.
- 13) This contract should be completed in full, signed by the Mare Owner and returned with the booking fee to the Breeder. Breeder will notify the Mare Owner within 10 days of approval. Upon notification, it will become a binding contract on both parties, subject to the above terms and conditions.
